Hello fellow TEX members. This is the second net "newsletter" to be published on a more-or-less regular basis to keep you informed of what is happening and hopefully inspire you to join us on TEX as often as you are able.

The communication efforts related to hurricanes Katrina and Rita, as far as NTS is concerned, have pretty much "wound down", although there are still many amateur radio operators working in the field to handle communications needs other than long-haul traffic on behalf of served agencies such as the Red Cross and Salvation Army.

Don, AC5XK, who is the STM of South Texas, provided me with some requested anecdotes about his and his section's participation in the hurricane Rita aftermath. I have included them here, and if you want more detail on the overall amateur radio response, there is a lot of information on the ARRL web site, in particular the ARES E-Letter, which you can access via http://www.arrl.org/ares-el/. Now for Don's contribution:

As for my involvement, I've been active in two ways: one involves handling traffic into LA and MS dealing with Hurricane Katrina. Overlapping that disaster was the Hurricane Rita effort. Hurricane Katrina produced so many Emergency and Priority messages that the Health and Welfare messages started seeming Routine. That is, until I looked at all the names, addresses and phone numbers of the individuals involved in the Health and Welfare messages. Then I realized the enormous scope of the disaster.

Whenever I passed an Emergency or Priority message by CW, I'm glad to report that the receiving station clearly understood the priority--I didn't have to repeat that part. Also, the rest of the message went smoothly and was acknowledged by the receiving station.

I picked through my backlog of Health and Welfare messages and passed those that I thought had the greatest chance of being delivered. In other words, I held back messages for New Orleans and other areas that had been entirely evacuated, with the intent of passing them later or via EOC contacts.

Regarding Hurricane Rita, in my role as South Texas Section Traffic Manager, I have scheduled net control stations on the 7285KHz voice emergency net that has operated

for about a week already (this was written on September 29 - Ed.). At first it operated 24 hours a day. Now it is only 8AM to 6PM. Stations involved in providing relief to the affected areas check in to coordinate supplies, communications, etc.

On CW, I continue to pass high priority messages. Many stations are unable to hear others due to propagation difficulties--not to mention the lack of commercial power, phone service, etc.

Thanks to everyone who has served as net controls on CW and other nets and has relayed traffic as it has been presented. 73, Don AC5XK South Texas Section Traffic Manager

Thanks, Don, for a job well done. All please join me in welcoming Bob, KC5T, who checked in with us this month from Houston. I would like to congratulate and thank Bert, AC5Z, who had the most QNI's to the early TEX net (18 out of 30), and Floyd, N5EL, who was just below this with 17 and also takes the "prize" for the most QNI on the late session – 17 out of 30. Floyd also had top overall QNI to both early and late – 34 out of 60. Thanks, men, I appreciate all the help and support you have provided.

Charlie, W5GKH, lives in an area that had a mandatory evacuation in preparation for hurricane Rita. He has returned home and found, thankfully, no major damage, but because he had lowered his antennas in anticipation of the strong winds, he is not yet on the air. He reports that he needs help to climb up on the roof to put them back up again and is awaiting assistance from his son, who lives in Houston and is busy with his own cleanup efforts. We miss you, Charlie, and eagerly await your return on the air.

Below is the schedule of NCS and RN5 liaison slots. Friday and Saturday are still problem days for RN5. Don and I have been filling in on them, as we are able, and also Don, Floyd, and I have been filling in Charlie's NCS and RN5 slots while he is temporarily off the air.
